**2. Purpose of processing:**

The photos and/or videos are used exclusively for public relations work by the VEREIN and its members partner organizations

**3. Legal bases of processing:**

Processing of photos and/or videos (collection, storage and transfer to third parties (see under 5.) takes place on the basis of the express consent of the legal guardian or the person concerned, or in accordance with Art. 6 Para. 1 Letter a DSGVO.

**4. Categories of recipients of the personal data**

The photos and/or videos can be passed on to partners such as AFS International or the umbrella organization AJA (Arbeitskreis gemeinnütziger Jugendaustausch) for public relations purposes within the international network of AFS and to partner organizations of the association for public relations purposes, always earmarked for the association's goals .

**5. Storage of personal data:**

Photos and/or videos that are made available/made for the purposes of the public relations work of the NGO are stored for an indefinite period, subject to revocation of the consent of the person concerned of the photos and/or videos can be revoked at any time for the future.

**6. Right of withdrawal the consent:**

The consent to the processing of the photos and/or videos can be revoked at any time for the future will. The legality of the data processing carried out on the basis of the consent until the revocation is not affected by this.

**7. Rights of data subjects:**

According to the General Data Protection Regulation, you have the following rights:

- a) If your personal data is processed, you have the right to receive information about the data stored about you. (Art. 15 DSGVO)
- b) If incorrect personal data is processed, you have the right to rectification (Art. 16 DSGVO)
- c) If the legal requirements are met, you can request the deletion or restriction of processing and object to the Submit processing (Art. 17, 18, 21 DSGVO)
- d) If you have consented to data processing or there is a contract for data processing and data processing is carried out using automated procedures, you may have the right to data portability. (Art. 20 DSGVO) If you make use of the rights mentioned, the person responsible will check whether the legal requirements for this are met. Furthermore, there is a right of appeal to the State Commissioner for Data Protection of the State of Hamburg.
